

## **PRIVACY POLICY**

World Smart Solutions Ltd ("Company") places a high priority on the privacy and integrity of the personal information of our Clients, both present and future and other visitors to the site. The Company strives to ensure the safety and confidentiality of all information received from the Client. This Privacy Policy (the "Policy") describes how the Company collects, uses and protects the personal information of the Client.

By opening an account, Client hereby consents to such collection, processing, storage and use of personal information by Company as explained below.

### **THE CLIENT'S PERSONAL DATA**

To open account, the Company will need certain information (Personal Data) about the Client.

### **THE PERSONAL DATA THAT IS COLLECTED BY THE COMPANY MAY INCLUDE:**

1. Information provided on application and other Company forms, such as name, address, date of birth, passport data, occupation, national insurance number, medical insurance number, and personal mobile phone number;
2. Financial information such as income, assets, investment experience;
3. Documents provided to confirm identity, such as passport, utility bills, and/or bank statements or company incorporation information;
4. Payment documents: money transfer orders, bank statements, bank card copies, etc.

### **USAGE OF PERSONAL INFORMATION/OPT OUT**

Company uses personal information only as required to provide quality service and security to you. This information helps improve services, customize browsing experience and enables us to inform you of additional products, services or promotions relevant to you and the products and services you require and you consent to us using this data for such purposes.

Although you are not required to provide Company any of the personal information that we may request, please note that failure to do so could result in Company not being able to open your account or provide you with the service you require.

Whilst we attempt to ensure that all the information we hold about you is current, accurate and complete, we urge you to immediately contact us if any of your personal details have changed.

### **PROTECTION OF PERSONAL INFORMATION**

Any personal information you provide us will be treated as confidential and shared only within Company and its affiliates and will not be disclosed to any third party except under any regulatory or legal proceedings.

The personal information that you provide in connection with registering yourself as a user of wssolution.com is protected in many ways. You can access your Registration Information through a password selected by you. This password is encrypted and known only to you and shall not be revealed to anyone else.

Registration Information is safely stored on secure servers that only authorised personnel have access to via password. Company encrypts all personal information as it is transferred to Company and thus makes all necessary effort to prevent unauthorised parties from viewing any such information.

## **PARTNERS AND AFFILIATES**

Company may share information with partners, affiliates and alliances in the event such information is reasonably required by such affiliate in order to:

1. offer additional similar products and services that meet your needs and which are delivered in a manner that is useful and relevant (only where you have authorized us to do so); and/or
2. service customer accounts.

## **NON-AFFILIATED THIRD PARTIES**

Company does not sell, license, lease or otherwise disclose personal information to third parties, except as described in this Privacy Statement.

Company reserves the right to disclose information as necessary to credit reporting or collection agencies as reasonably required in order to provide the services to you.

To help us improve our services, Company may engage third parties to help carry out certain internal functions such as account processing, fulfillment, client service, client satisfaction surveys or other data collection activities relevant to our business. Use of the shared information may also be used to provide professional, legal, or accounting advice to Company. Use of shared information is strictly limited to the performance of the above and is not permitted for any other purpose. All third parties with which Company shares personal information are required to protect such personal information in accordance with all relevant legislation and in a manner similar to the way Company protects the same. Company will not share personal information with third parties which it considers will not afford its Clients the required level of protection.

Where you have been introduced to us by a Business Introducer, such Business Introducer may have access to your information. You hereby unambiguously and unequivocally consent to the sharing of information with such Business Introducer.

You acknowledge that in order to provide services to you, it may be necessary for information to be transferred outside of the European Economic Area and you consent to such transfer.

## **USE OF "COOKIES"**

Cookies are small text files sent by a web server and stored on a visitor's browser which are read later by the server when the visitor returns to the site. Cookies store information such as passwords (encrypted), usernames, shopping cart, certain preferences, etc. allowing visitors to visit sites repeatedly without having to enter the same information over and over. Cookies are not used to determine the personal identity of anyone visiting the site.

## **REGULATORY DISCLOSURE**

Company reserves the right to disclose personal information to third parties where required by law, regulatory, law enforcement or other government authority of a competent jurisdiction in order to protect our rights and/or to comply with such legal proceedings. Such disclosure shall occur on a 'need-to-know' basis, unless otherwise instructed by a regulatory or other government authority. Under such circumstances, Company shall expressly inform the third party regarding the confidential nature of the information.

## **RESTRICTION OF RESPONSIBILITY**

Company is not responsible for the privacy policies or the content of sites wssolution.com links to, and has no control of the use or protection of information provided by Client or collected by those sites. Whenever Client elects to link to a co-branded website or to a linked website, Client may be asked to provide registration or other information. Please note that such information is recorded by a third party and will be governed by the privacy policy of that third party.
